

Safeguarding Policy Statement

- **2. Policy Statement**: The Global Diplomatic Forum is dedicated to creating a safe and secure environment for children and young people. Prevention and Risk Management**: 6.1 Staff and Volunteer Recruitment: All individuals engaging in activities involving children and young people will undergo a thorough recruitment process, including background checks and reference verification. 6.2 Code of Conduct: The Global Diplomatic Forum has a clear code of conduct that outlines expected behavior towards children and young people, including guidelines on appropriate physical contact and the use of language. 6.3 Training and Awareness: Staff, volunteers, and relevant stakeholders receive regular training and updates on safeguarding policies, procedures, and indicators of abuse. This includes awareness of online safety and the prevention of

cyberbullying. 6.4 Risk Assessment: Regular risk assessments are conducted to identify potential hazards and mitigate risks to children and young people during activities and events.
